Dear Parent/Guardian,

It is my pleasure to announce that through a partnership between the Manteca Unified School District (MUSD) and the Manteca Unified Student Trust (MUST) we are able to offer a 2009-10 Flag Football program. The program involves a minimum of 5 competitive games played between your child's school and other schools in Manteca Unified. In addition to the normal league games, each team will be invited to participate in a district wide tournament sponsored by MUST. The league season will begin September 14<sup>th</sup>, 2009 and go through October 12<sup>th</sup> with the MUST tournament being held the weeks of October 19<sup>th</sup> and October 26<sup>th</sup>, and finals being held the week of November 2<sup>nd</sup>, 2009. Your child's coach has scheduled practices for:

In order for your child to participate, your child must:

1. Be eligible (2.0 GPA, no more than one F academic grade and no more than two U Citizenship grades.)
2. On game days, players must have been in attendance at least a minimum school day (180 instructional minutes) to be eligible to participate in the game.
3. Wear appropriate shoes and clothing.
4. Be responsible for caring for and returning the uniform.
5. Parents are expected to arrive on time to pick up their child from practice and from games. Parents must provide signed written notes when child is riding with or being picked up by an adult other than his/her parent.
6. Complete an emergency card (in event of injury).
7. Have insurance in the event of injury or accident. Sports insurance forms are available in the school office should your child need insurance.

**Please complete the permission slip below and return to your child's coach at practice along with the emergency treatment consent form and cash or money order for \$35 to the MUST Foundation. NO Refunds.**

I give my permission for my child to participate in the MUST/MUSD Flag Football Program. I understand that it is the parent's responsibility to provide insurance, transportation after practice and to and from games, and that a written note signed by the parent/guardian must be given to the coach when my child is going to be riding with another adult.

In consideration of the acceptance of my child's application into the Flag Football program, I hereby waive, release and discharge any and all claims for damage for death, personal injury or property damage which I may have, or which hereafter accrue to me against Manteca Unified and MUST as a result of my or my child's participation in the program. This release is intended to discharge both Manteca Unified, and MUST, their agents and employees, volunteers, and any other involved individual or public entities from and against any and all liability arising out of or connected in any way with my, or my child's participation in the program even though the liability may arise out of the negligence or carelessness on the part of persons or entities mentioned above. I further understand that accidents and injuries can arise out of the program; knowing the risks, nevertheless, I hereby agree to assume those risks and to release and to hold harmless all of the persons and or entities mentioned above to assume those risks and to release and to hold harmless all of the persons and entities mentioned who (through negligence or carelessness) might otherwise be liable to me (or my heirs or assigns) for damages. It is further understood and agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns.
